Artists may only show work in categories approved by the jury and that must be original work of the exhibitor – no buy/sell merchandise will be allowed.

Space will be available for set up on the day of event starting at 7AM. All exhibitors must be set up by 9:30 AM on the day of the event. Event staff will be on site to assist as available. We will have special parking available for exhibitors.

Due to the setting of the event, the ground may not be level so please be prepared. Exhibitors must also provide their own tent, chairs, tables, etc.
